All abstracts will be subject to blind review and only those abstracts approved by the reviewers will be selected to submit their complete paper for the final presentation. The criteria for evaluation by the reviewers are based on relevance, methodology and originality. Participants willing to submit the Abstract must submit the same in .doc/docx format to ncai@slnagpur.edu.in with the subject "Abstract Submission" by 11:59 PM., 30 December, 2023.
