#### 4. The Practice

In order to address the concerns of water shortage in the city and the significance of water conservation, the Legal Aid Centre at Symbiosis Law School, Nagpur, launched ISR activities on two fronts: first, educating people about the usage of dipper lights in automobiles while driving at night. Raising public awareness of the potential dangers associated with careless usage of high beams during nighttime driving was the main objective of the first program.

Members of the Legal Aid Centre and students from Symbiosis Law School in Nagpur took part in the National Maha Lok Adaiat, which was held at the district court in Nagpur. Students had the priceless opportunity to observe and participate in actual court procedures, learning about a variety of legal aspects.

#### 5. Evidence of Success

The significant result of this experiential learning program offered by Legal Aid Centre is that students gain a deeper comprehension of the real-world difficulties. These programs not only helped the students become better lawyers, but they also made them feel more socially responsible to help others in need of legal assistance. In the end, experiential learning gives students the confidence and practical knowledge they need to move smoothly from the structured, academic environment into the fast-paced, demanding field of legal practice.

#### 6. Problem Encountered and Recourses Required

During experiential learning in the above –mentioned events students encountered challenges such as bureaucratic hurdles, delays in getting responses, or the need for expert legal guidance. ### Use of Upper/Dipper Lights in Motor Vehicles

#### Awareness on save water

The Legal Aid Centre at Symbiosis Law School, Nagpur conducted ISR activities on two issues: first, raising awareness about the use of dipper lights in vehicles while driving at night; and second, addressing the issue of water scarcity in the city and the importance of water conservation. Total 30 students participated in the awareness program. Team of the students were divided in groups.

The Legal Aid Centre at Symbiosis Law School, Nagpur, conducted an awareness program on road usage while driving. The primary focus of the program was to raise awareness among people regarding accidents that may occur due to the negligent use of high beams during night driving. The awareness program started from March 28<sup>th</sup>, 2024, to April 20<sup>th</sup>, 2024, in the city of Nagpur.

This awareness initiative was conducted as part of Pro Bono Services under the esteemed leadership of Dr. Sukhvinder Singh Dari, Director of SLS Nagpur, and under the guidance of Dr. Deepti Khubalkar, Faculty In-charge of the Legal Aid Centre. The aim of the program was to raise awareness and collect data related to the usage of upper/dipper lights in motor vehicles and the challenges faced by pedestrians and drivers due to the use of high beams in urban areas.

Awareness activities took place at various locations including Medical Square near V.R Mall, Nandanwan, Dharampeth, Wathod and Wardhaman Nyohar. The student team successfully collected 110 responses. According to the data collected and interactions with the public, it was observed that while people are aware of the difference between upper and dipper lights, the majority of them encounter difficulties while driving due to the prevalent use of high beams by riders. Out of the 110 responses, 97 individuals reported facing difficulties in night driving due to the use of high beams or LED lights by oncoming vehicles.

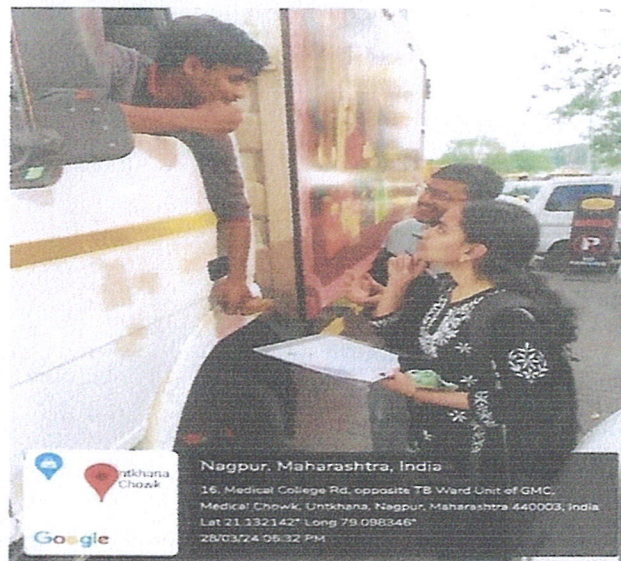

The second awareness program was conducted in East Nagpur regarding the water issues faced during summer and the available water sources for the residents. Participants were queried about the water supply provided by the corporation and the of the water received. It was reported by the locals that the water supply is limited to morning hours. At times, when the water is not supplied or during the rainy season when the water becomes muddy, residents rely on water tankers provided by the corporation or fetch water from wells. It was observed by the students that some wells in the area are not adequately maintained. Some wells are full of garbage.

### **Report on Student Participation in National Maha Lok Adalat at District Court, Nagpur**

**Date: 3/3/2024**

#### **Legal Aid Centre, Symbiosis Law School, Nagpur**

On 3<sup>rd</sup> March, 2024, students of Symbiosis Law School, Nagpur, and members of the Legal Aid Centre, actively participated in the National Maha Lok Adalat organized at the District Court in Nagpur. The event provided an invaluable opportunity for students to witness and engage with real-life legal proceedings, gaining insights into various aspects of the legal system.

The National Maha Lok Adalat at Nagpur District Court focused on resolving cases through alternative dispute resolution mechanisms, emphasizing conciliation and settlement. The cases presented ranged from bank debt recovery issues to complex land disputes, offering a diverse and comprehensive exposure to legal challenges. The students observed multiple bank debt recovery cases where financial institutions sought to recover outstanding debts through legal proceedings. This experience deepened their understanding of the intricacies involved in such cases, including the legal frameworks governing debt recovery. Further, the land dispute cases showcased the property rights and the varied approaches taken to resolve such matters. The students witnessed firsthand the challenges faced by individuals involved in these disputes and the role of legal mechanisms in finding equitable solutions.

Total 12 members of the Legal Aid Centre actively engaged in the lok adalat alongwith the staff of DLSA, Nagpur understanding the procedure of settling the pending matters of the litigants, procedural aspects, and the benefits of alternative dispute resolution. This allowed students to comprehend the practical application of legal knowledge and the significance of legal aid in ensuring access to justice.

The panelists for the Lok Adalat were esteemed judges from the District Court, Nagpur. Their expertise and experience in adjudicating disputes added significant value to the event, creating a platform for meaningful discussions on dispute resolution techniques. Participation in the National Maha Lok Adalat proved to be an enriching experience for the students of Symbiosis Law School, Nagpur. The exposure to diverse cases broadened their perspectives on legal issues, while witnessing the proceedings in a real courtroom setting enhanced their understanding of legal processes. The event also highlighted the importance of conciliation and settlement in legal practice, emphasizing the potential for amicable resolutions outside traditional courtrooms.

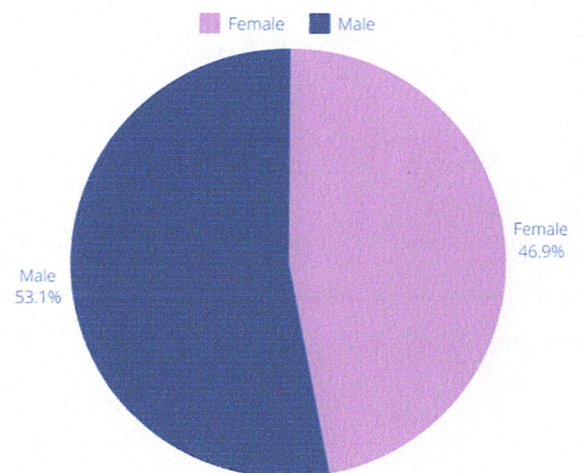
# INCLUSIVITY AND DIVERSITY

## REGIONAL DIVERSITY



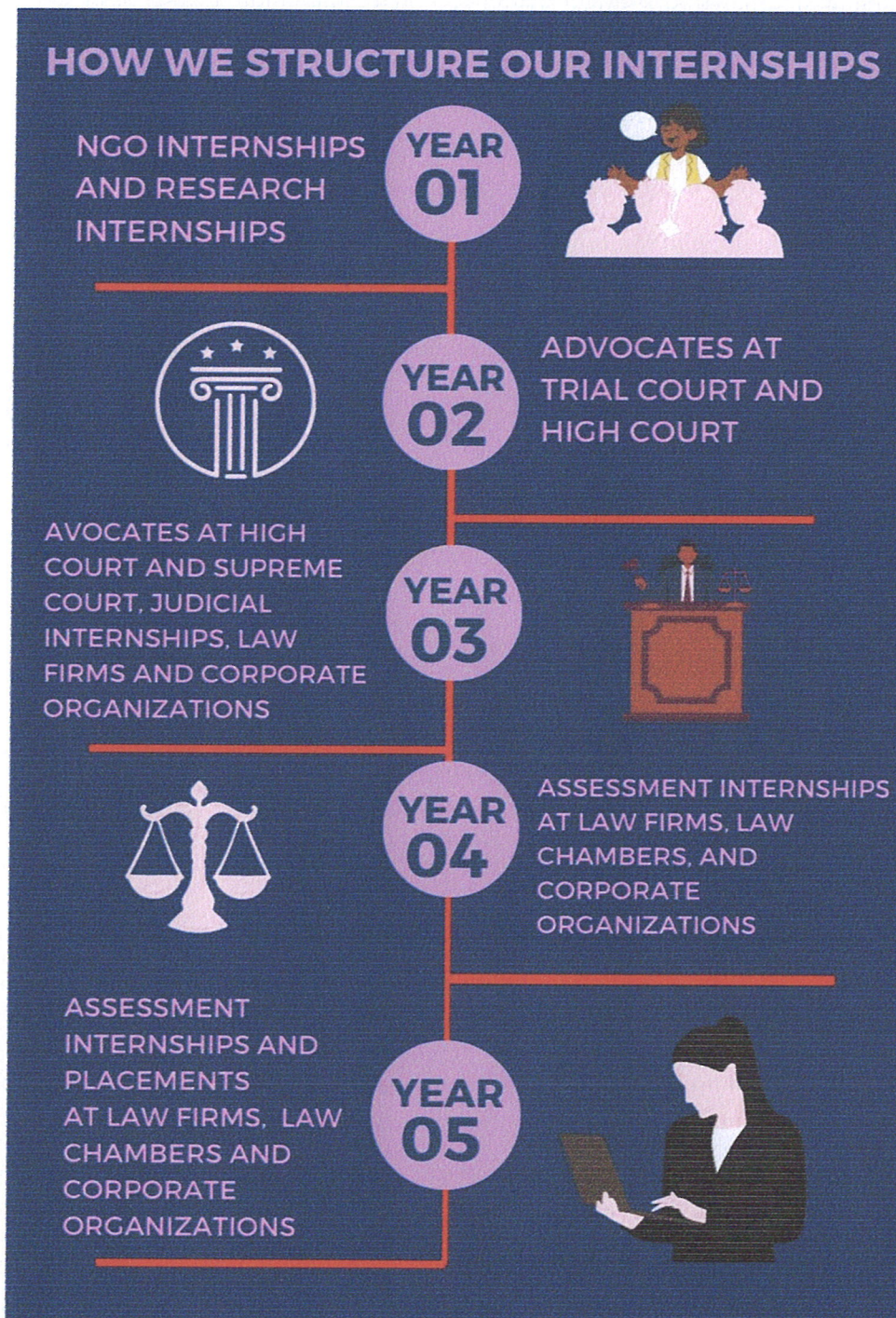

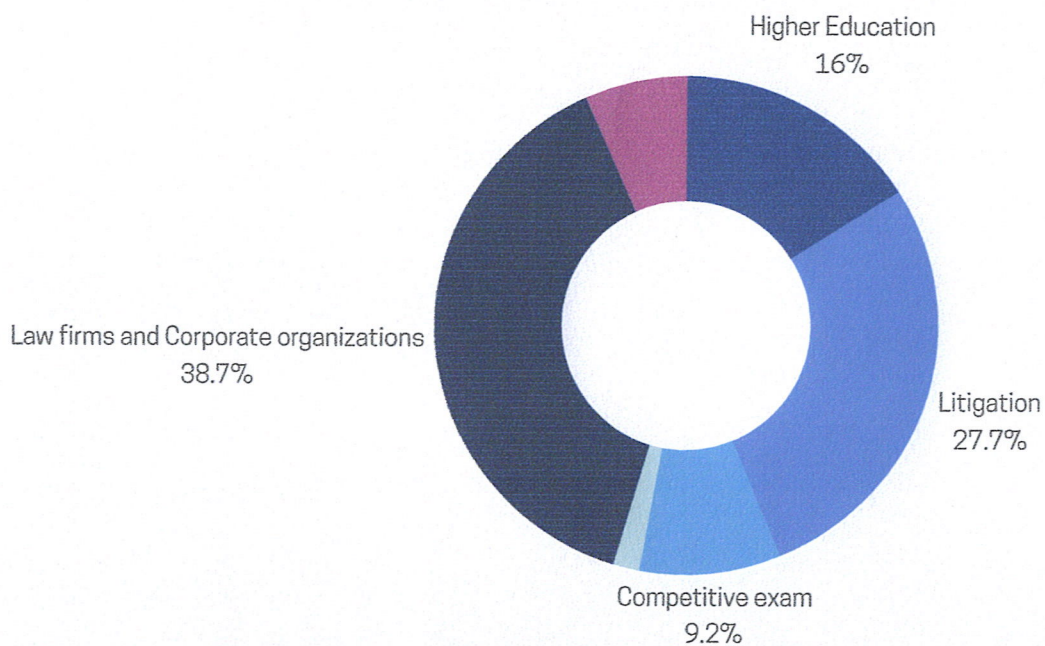

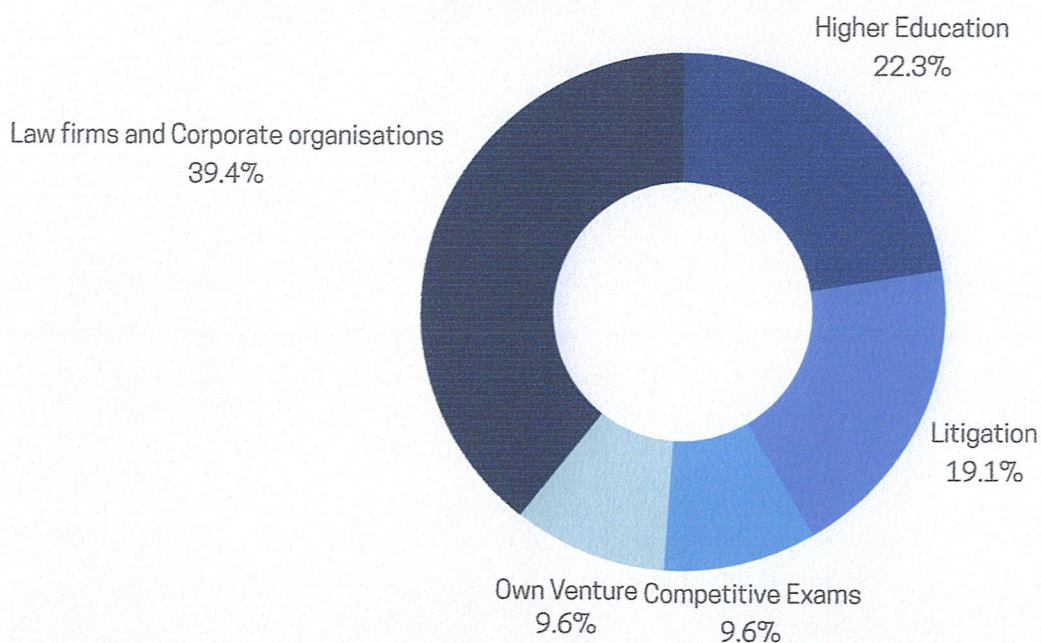
## BATCH STATUS OF 2019-24:

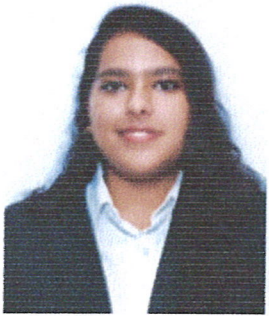

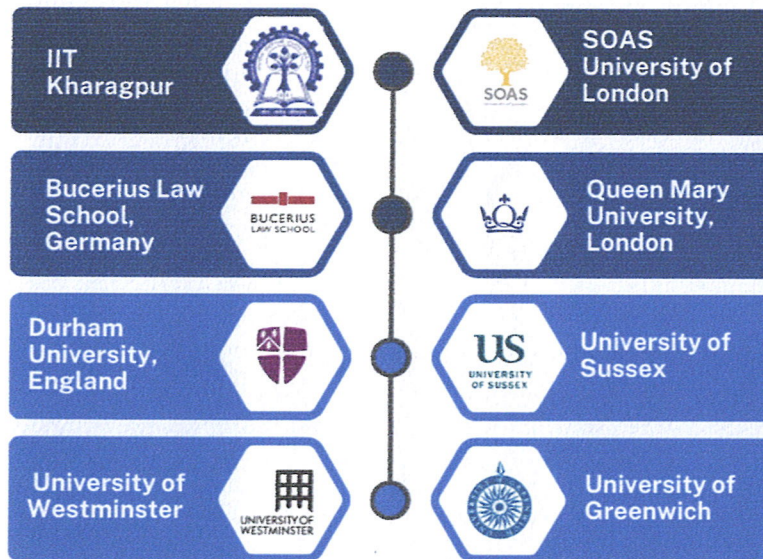
