22nd September 2022

Taking forward its legacy of Internationalization Symbiosis Law School, Nagpur organized a Guest Lecture of **Joan Bellefield Davis, Esquire**. Madam is a council at Schroder Brooks Law Firm PLC. In addition to this she has worked with former Chief Justice Harry L. Carrico of the Supreme Court of Virginia, U.S.A. She had addressed the students on the topic: **An Introduction to practicing Fashion Law in U.S.A** on 22nd September 2022 as a part of International Lecture Series.

Dr. Sukhvinder Singh Dari, Director at SLS, Nagpur welcomed the Guest and thanked Miss. Joan Bellefield Davis for considering our invitation and agreeing to deliver a lecture on the emerging topic of Fashion Laws. The session was moderated by Ms. Shivangi Kurup, student of second year.

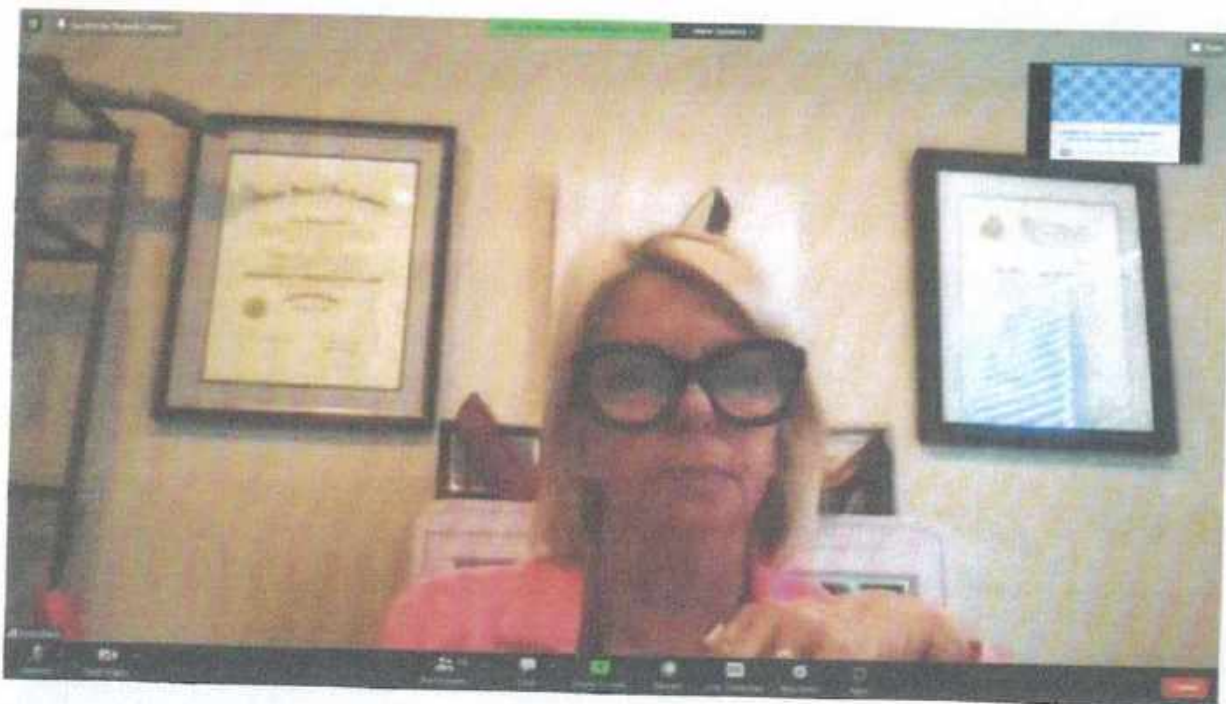
Ms. Joan highlighted the basics of fashion law with respect to trademark registration, copyright registration, and counterfeits in the U.S. luxury goods market. Fashion Laws in USA are very much intertwined with Intellectual Property Laws. She also discussed about how in the fashion business, the role of reputation is vital. The logo of the brand must be unique so that it's easy to spot it out. She discussed the famous case of "Christian Louboutin S.A. V. Yves Saint Laurent AM," which showed that uniqueness of a trademark is important because when a unique trademark gets registered, it gets secured beyond the acquiring of rights by using a mark.

Subsequently she moved on the topic of "Copyright Laws" and also provided an insight of what Copyright is and how they fall in the ambit of Fashion Laws. The Copyright Act provides protection for pictorial, Graphic and sculptural work which include two- dimensional and three-dimensional works of: fine, graphic and applied art then photographs, prints and art reproductions, maps and globes and Charts, diagrams, models and technical drawings. Along with Copyright she touched on the topic of Trade dress and separability and Design Laws. Trade dress is a 'total image and appearance of the product' it can include colour, shape, size, texture, particular sale technique. To get registered under trade dress one needs to be established and source identifier. She illustrated Trade Dress and Separability with the case of Star Athletica, L.L.C. v. Varsity Brands U.S. March 22, 2017. In the session she further mentioned that Unlike trademark, copyright laws protection under design is accessible. One doesn't need to have a big name or brand to get protection under design: the only ingredient that is needed is a meritorious piece of art. The procedure is very similar to that of Copyright but the design includes 3D prints, patterns, shapes.



She further asserted on the topic patents and the protection under it, there are two types of patent protection granted design patent and utility patent. Design patent for a garment can be done when the dress is innovative in the shape, colour, pattern, or entire product. To get a design patent the good has to be novel and something that has never existed before. In the case of *Lululemon Athletica v. Calvin Klein: battle of yoga pants* was a case that seemed a game changer for the fashion industry since patent lawsuits are hard to win in the apparel industry.

The Session proved to be an excellent learning platform for Law students across the country with a participation of more than 100+ attendees. The session was followed by the very exhilarating and captivating Question & Answer session. **Prof. Ahmar Afaq** extended the formal vote of thanks.

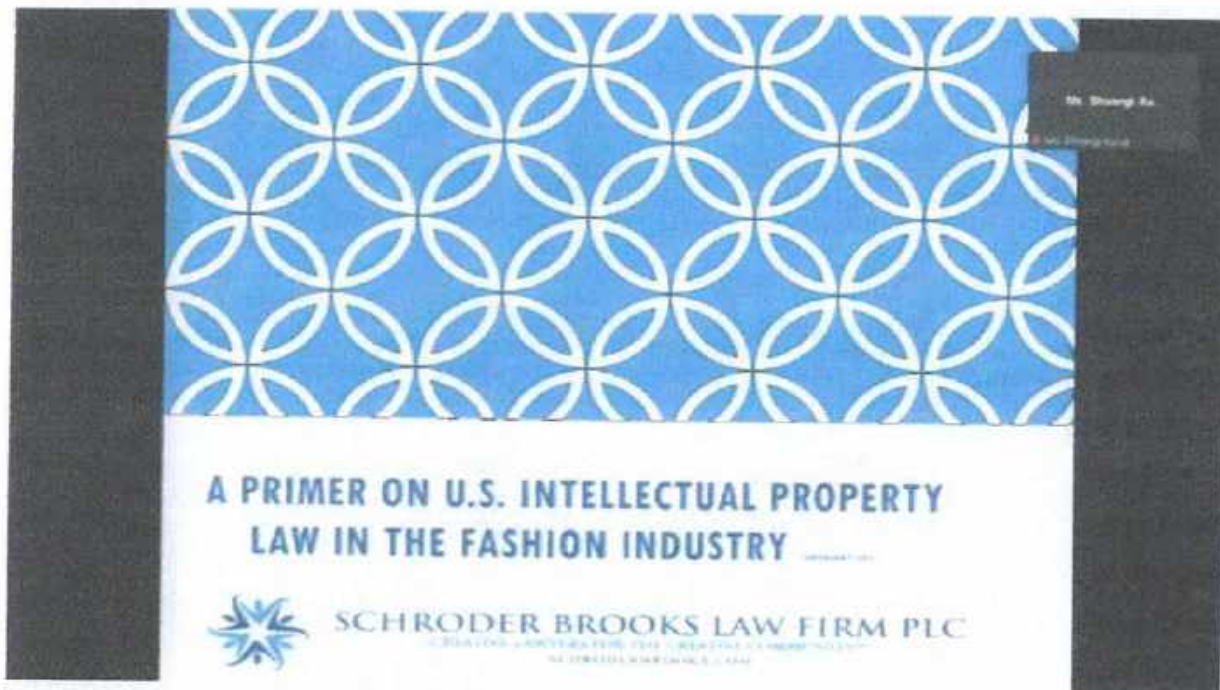

Workshop on "Fundamentals of Academic Writing"

Date: 7th December, 2022

Symbiosis Law School, Nagpur as part of its continuous efforts in providing quality legal education and exposure, organized a workshop on "Fundamentals of Academic Writing" for the LL.M. students on 7th December 2022 from 02:00 pm onwards. The resource person for the workshop was Ms. Tiffany Williams Brewer, Former Judge and Assistant Professor at Howard University School of Law, Washington D.C, USA. The event was organized as part of its efforts towards internationalization of legal education undertaken by the International Cell, SLS Nagpur.

The workshop commenced with the introduction of Ms. Tiffany by Ms. Tanya Vats, a student of LL.M. Ms. During the Workshop, she conveyed the complexities of fundamental writing to the students through a special blend of lectures, discussions, and problem-solving activities. The session initiated a discussion on identifying a suitable topic for research. In addition to offering advice on how to select a topic that is appropriate for legal writing, Ms. Williams urged her students to trust their own judgment and choose topics that they were passionate about themselves. She advised keeping a record of any thoughts, ideas, and perspectives they may have and documenting in a journal to record thoughts as they come to you. After that, she instructed the students to choose a topic for their legal writing and to jot down a date on which they planned to start their research. She gave advice regarding the need for students to set and adhere to a deadline for finishing their research. She gave examples on issues that are pertinent in the United States of America including issues of racial discrimination, under-representation of women in the judiciary, etc. Her insights into the same gave the participants the required thrust in developing a critical approach in identifying the topic and addressing the contemporary socio-legal issues in society.





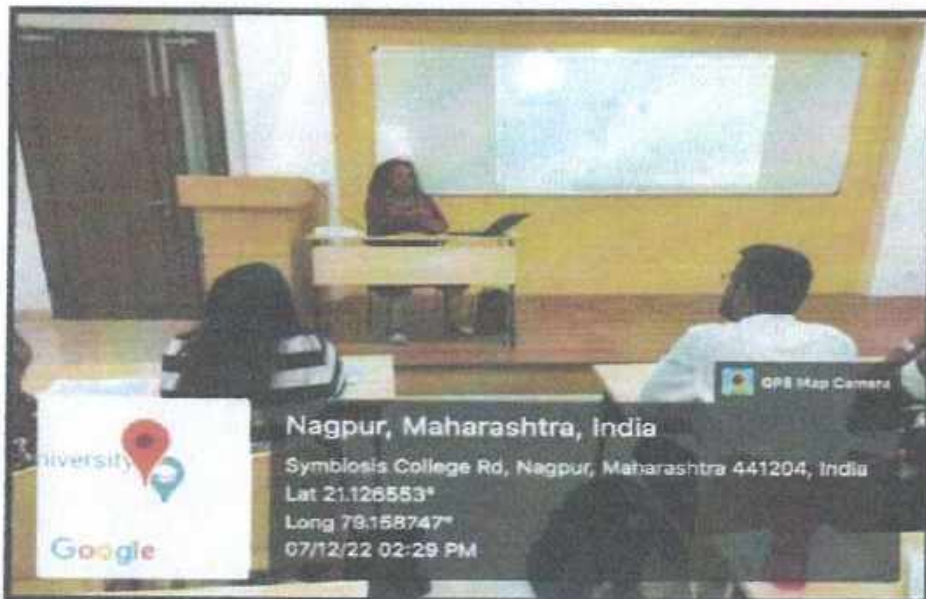

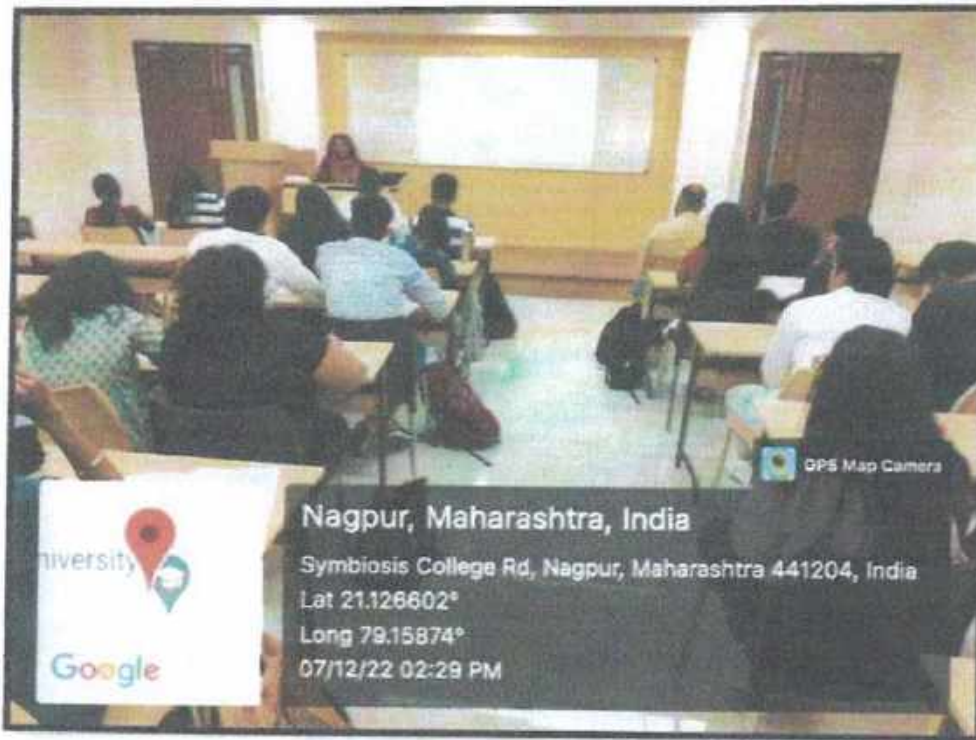

Training Workshop on "Mooting and Advocacy Skills"

Date: 8th December, 2022

Mooting and Advocacy skills are core skills for being a quality legal professional. In order to provide insight and train the students, the International Cell of Symbiosis Law School, Nagpur organized a Training Workshop on "Mooting and Advocacy Skills" on 8th December 2022 for the First-year students. The resource person for the workshop was Ms. Tiffany Williams Brewer, Former Judge and Assistant Professor at Howard University School of Law, Washington D.C. USA. The workshop was organized as part of its efforts towards the internationalization of legal education as well as equipping the students with the skills for their professional careers.

The workshop commenced with the introduction of Ms. Tiffany by Ms. Nikitaa Bhardwaj, a First-year student of BBA LL.B. The Resource person was felicitated and welcomed by Dr. Sukhvinder Singh Dari, Director, Symbiosis Law School, Nagpur. In his welcome address, Dr. Sukhvinder Singh Dari emphasized how at the Institute since its inception in 2019, activities to provide global exposure to the students were conducted. He mentioned how even during the COVID-19 pandemic, initiatives through online lectures and workshops were continued as part of those efforts. He thanked Ms. Tiffany for her invaluable support in conducting the training workshop.

Ms. Tiffany began by elucidating the objectives of the workshop including providing insight in the lawyering skills in moot exercises and the purpose and process of legal writing. She provided a roadmap for students in honing their skills in oral and written communication. She emphasized how the writing must be persuasive which could be only undertaken after identifying the clients' interests, identifying the issue, and framing it appropriately. She additionally emphasized how as a lawyer one must value what the client values, and also explain to the client the same with reference to the applicable law and authorities. During the workshop, she used audio-visual content for the participants to reflect, review and evaluate the same as prospective legal

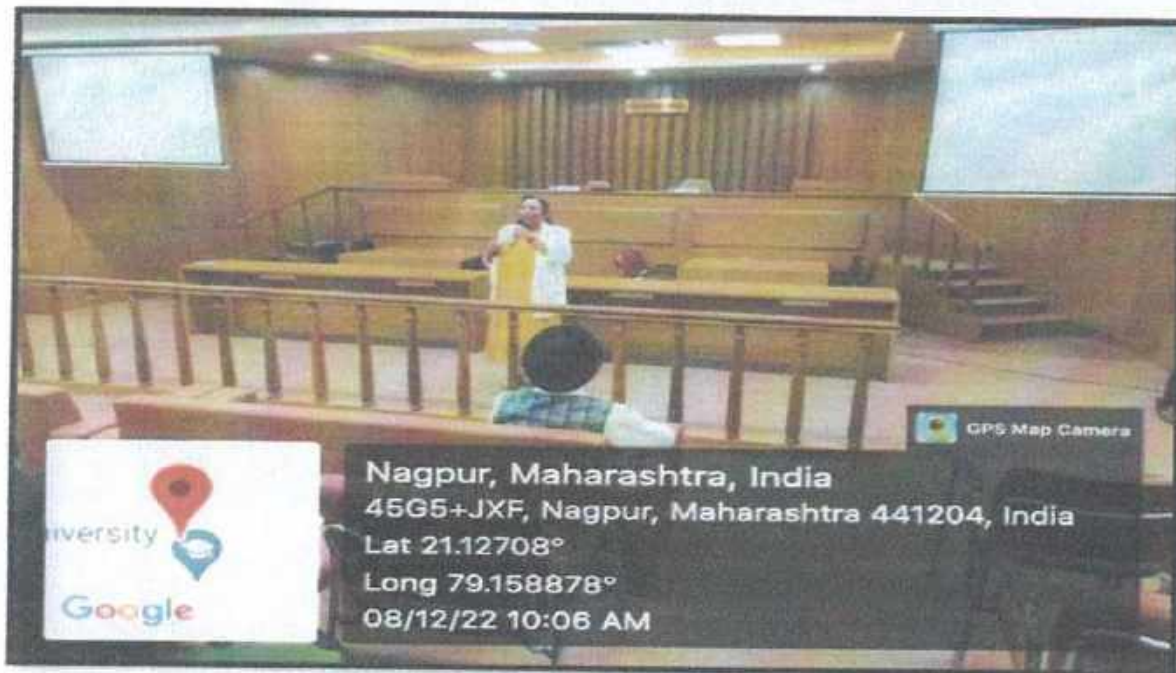

Date: 7th December, 2022

As part of the two-day visit of Ms. Tiffany Williams Brewer, Former Judge and Assistant Professor at Howard University School of Law, Washington D.C, USA, a faculty interaction was organized on 7th December 2022. The interaction was organized to facilitate sharing of best practices and methodology for enriching the teaching-learning process.

Ms. Tiffany gave a brief presentation on "Engaging with the 21st Century Change Agents in the Classroom". During her presentation, she brought out the changes in the students in the classroom unique and distinct from their counterparts a decade ago. She highlighted how the generation of the students is one with passion, compassion, and questions, and challenges to the status quo. Additionally, their command over technology provides them with unlimited potential. She highlighted how the same also put forward certain challenges to engage and empower them. She provided some experiences and practices that she undertook to ensure the students are engaged and involved in the classroom teaching-learning process. She emphasized how as faculties we must remain relevant and remain abreast with global legal and societal issues. She further mentioned how varied assessment techniques help students discover issues, and identify their passion and purpose. The same then faculties must support it and be aligned with their legal career.

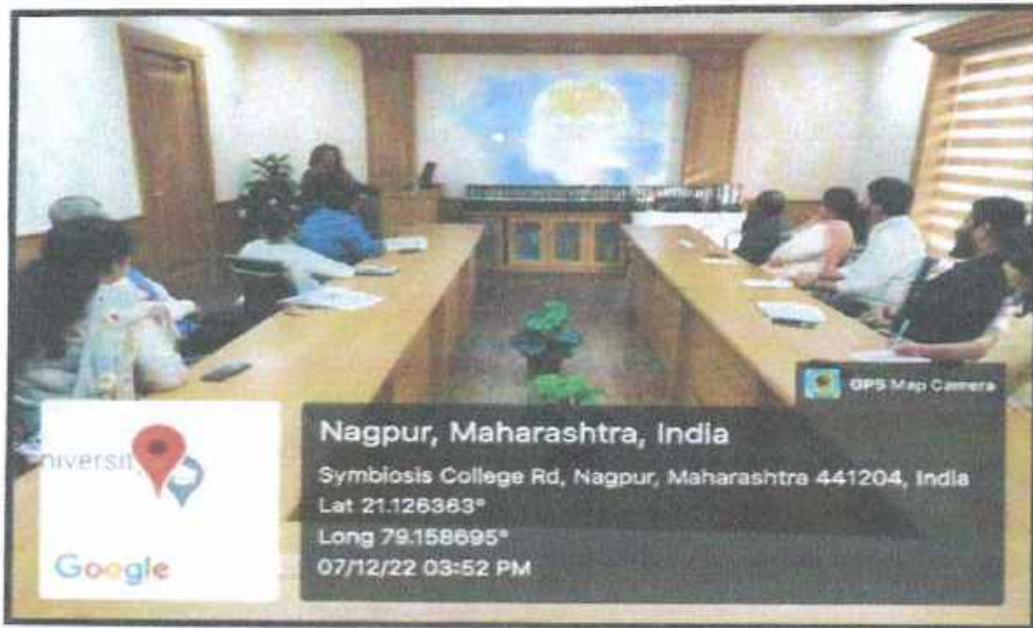

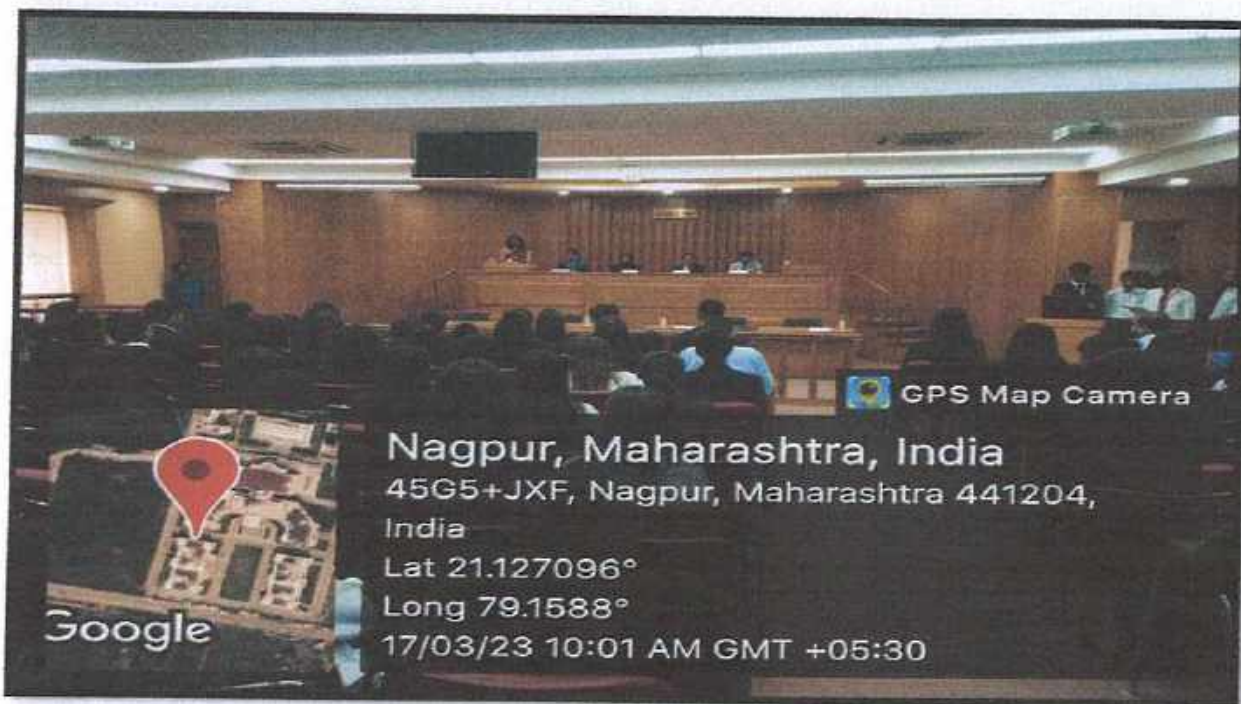



Taking forward its legacy of Internationalization Symbiosis Law School, Nagpur organized a Guest Lecture of **Mr. Salvatore Tolone Azzariti, Professor at Oxford University and Universidad de Buenos Aires, Argentina**. He is a distinguished professor & expert with years of experience in Private Law.

Mr. Tolone Azzariti holds a PhD in private law from the University of Rome, and has taught at several prestigious institutions around the world. He is currently a Professor of private law at Oxford University, and a Professor of private law at the Universidad de Buenos Aires in Argentina. He had addressed the students on the topic: **Accidentalia Negotii & Modern Dynamics of Patrimonial Rights** on April 13, 2023 as a part of International Lecture Series.

Prof. Ahmar Afaq, Faculty In-charge, International Cell, SLS Nagpur welcomed the Guest and thanked **Mr. Salvatore Tolone Azzariti** for considering our invitation and agreeing to deliver a lecture on such an interesting topic. The session was moderated by Mr. Prateek Singh, student of second year.

Prof. Azzariti highlighted the basics of Accidentalia Negotii & Modern Dynamics of Patrimonial Rights with respect to world at large. Accidentalia Negotii is a Latin phrase that means "incidental aspects of a legal transaction." He also referred how these ideas to numerous conditions or occurrences that are not part of the essential terms of a contract but may nonetheless impact the parties' rights and duties. He also explained the following concept with an example: Incidental features of a legal transaction include the timing of a payment, the occurrence of an unexpected event, or the occurrence of a change in circumstances. In such instances, the law may order the parties to amend the contract's terms or compensate one of the parties.

Subsequently he moved on the topic of "Modern Dynamics of Patrimonial Rights" and also provided an insight of what Modern Dynamics of Patrimonial Rights is and how these two concepts are intervened with each other. He explained these concepts though what is happening in today's fast-paced, linked world, and how patrimonial rights are vulnerable to a variety of complicated and dynamic elements that might impact their value and enforceability. Due to technological advancements, global economic movements, and changes in legal and regulatory frameworks are among these drivers. As a result, contemporary legal systems have had to evolve



in order to keep up with these developments and guarantee that patrimonial rights are safeguarded efficiently and effectively. The process of interpreting and using the idea of Accidentalita Negotii can be complex and difficult according to him because of said reason. The requirement to preserve the interests of the parties concerned must be balanced with the need to guarantee that legal transactions are efficient and effective manner. In real world practice according to him, this necessitates thorough analysis of the facts of each case, as well as knowledge of the legal and regulatory frameworks that govern the transaction.

The session was followed by the very exhilarating and captivating Question & Answer session in which he dealt with a number of questions posed by the student who were present in the virtual lecture. He defined the difference between the limitations and challenges of using Accidentalita Negotii to determine patrimonial rights in the current legal landscape. As well as other intriguing question put forth before him.

The Session proved to be an excellent learning platform for Law students across the country with a participation of more than 100+ attendees. **Prof. Ahmar Afaq** (Faculty in-charge of International Cell) extended the formal vote of thanks to the professor **Salvatore Tolone Azzariti**.

Amongst key reasons identified in past studies, lack of knowledge of the law, awareness of rights, and pervasive discrimination against certain groups, are key obstacles to accessing justice in the Maldives. Procedural and geographical



barriers also prevent victims and vulnerable groups from accessing services in the capital and city regions, and lawyers from traveling to remote islands to provide legal services. Thus, affordability of travel and legal fees adds to the accessibility of receiving timely legal services and justice. Lack of services and affordability of services therefore present a significant barrier for vulnerable groups, such as women, who note that the number one reason affecting access to justice for them is the lack of access to lawyers, followed by difficulties in filling service and court application forms. A large percentage of the surveyed population of women also confirm that access to legal information presents a key barrier, and that this prevents them from pursuing protections and legal remedies otherwise guaranteed in the law. Women also note that lack of awareness of the system and the cost of legal services also present key challenges for women in accessing justice. Given the high cost of legal services, and lack of economic independence of women, an overwhelming seventy per cent of women indicate that they choose an out of court settlement and decide not to pursue legal action in a court.

Despite constitutional prohibitions on any form of discrimination based on gender, there are pervasive and continuing gender inequalities in the legal and justice system in the Maldives. This also includes the laws in effect, that directly and indirectly discriminate against women, or create a position of vulnerability for women by the implementation of the law. Key examples of such laws directly discriminating against women include the Family law Act and the Sexual Offences Act. Thus, while the Constitution has facilitated progressive legislative developments in the Maldives, there is a lack of policy and strategy to address the gender bias in the system.

Through NSAP 2019-2023, the Maldives Government committed to enhance access to justice by creating legislation, procedural laws, regulations, strengthening capacities of professionals, and implementing databases to strengthen case management. The Government has successfully created and amended a significant number of laws including, civil procedure code, evidence act, criminal procedure code, since 2019, and is currently conducting capacity building for legal professionals working for the State and the judiciary. Multiple data and/or case management systems are in the development stage and are yet to be fully developed and functioning, before a proper impact assessment can be done.

The conference will see the launching of ERI's Access to Justice after NSAP 2019-2023 Reforms - Political Process Monitoring Study Report, and will include paper presentations on the progress made in advancing access to justice nationally and internationally, particularly in relation to the efficiency of legal and judicial services, access to legal information, accessibility to the system, and the provision of legal aid in the Maldives mirroring it to the international, and challenges faced in accessing justice globally.
