Legal Aid Awareness

The SLS, Nagpur, is unusual in that it focuses on spreading legal awareness in the surrounding areas as well as to the underserved.

Objectives of the Practice:

The goal of Legal Aid Awareness is to give social-legal assistance to the community's destitute and needy members. The practical features of the legal profession must be understood by law students. Students give legal assistance with the assistance of professional practicing lawyers. A legal aid center serves as an ideal policy to gain practical work-experience which helps in securing a platform for discussion and information-sharing for the purpose of promoting and protecting the rights of individuals, especially those belonging to the marginalized sections of the society. The study involved in the legal aid camps acts as a valuable resource for law students.

Legal Aid Centre:

The Legal Aid Centre at Symbiosis Law School, Nagpur is established with 'Aim & Objective' to 'Serve legal aid, through human resource, knowledge resource, & infrastructural resource, to those who need it the most, purely on pro-bono basis'. It's a blend of legal duty (as laid down under Rule 31 of Bar Council of India's Rules of Legal Education, and Rule 11 of Schedule III of the said 'rules') of the Institute with mission of the Symbiosis International University.

The institution has established a Legal Aid Clinic under the supervision of a Senior Faculty Member who will administer the Clinic run by the students of the Institution in cooperation with the Legal Aid Authorities with list of voluntary lawyers and other Non-Government Organizations engaged in this regard in the locality generally from which the student community of the Institution, hail from.

The mission statement of the Symbiosis International University says that it is committed towards 'fostering spirit of national development', 'instilling sensitivity amongst the youth towards the community', 'contributing towards knowledge generation and dissemination', and 'promoting ethical and value based learning'. The establishment of the Legal Aid Centre at Symbiosis Law School - Nagpur acknowledges that it is committed towards fulfilling its 'institutional social responsibility'.

Participation of members of the Legal Aid Centre in various activities will make them more sensitive towards various legal issues that are being faced by the society people. It will enhance their understanding of their 'moral duties towards the society', which will lead to 'sense of responsibility in nation building'.

With these 'Aims & Objectives', the Legal Aid Centre of Symbiosis Law School, Nagpur will be active in three directions

LEGAL AWARENESS

Target population, as per the kind of activity, will be made more aware of the legal issue that is being taken up by members of the Legal Aid Centre. This awareness will be created through personal interaction, through pamphlets & posters, and through various other similar modes.

LEGAL LITERACY

Target population, as per the kind of activity, will be taught how to draft very basic legal documents, like, 'writing complaint', 'writing application under the R.T.I. Act', 'drafting an affidavit', and similar other documents.

CORE LEGAL AID

The aided person/s, as per requirement of the situation/case, will be given core legal aid, like, 'giving advice as per the legal provisions', 'bringing aided person/s before legal forum/authority', 'presenting case of the aided person/s before legal authority/forum', and similar other activities.

COMPOSITION

- The Legal Aid Centre at Symbiosis Law School Nagpur constitutes of a 'Head' of the Centre, and 30 'Para-Legal Volunteers'. A senior faculty member is being appointed as 'Head', and students have been appointed as 'Convener', 'Co-Convener' And 'Para- Legal Volunteers'.
- The Centre, with all the required infrastructural facilities, is situated at Ground Floor of campus of the Symbiosis Law School Nagpur; it is open six days a week (Monday to Saturday) from 9 am to 5 pm.
- It welcomes all to come & participate, both the ways, as a resource person, or as a needy person.

Legal Aid Centre is a law school program for law students to work on cases which require legal advice and assistance at no cost to the client mainly rendered to indigent persons and persons with low incomes. It aims to bridge gap between what law promises to offer and the harsh realities of law and society thereby implementing the concept of good governance by way of citizen participation. It seeks to impart practical knowledge to law students and provide an opportunity to implement the law by engaging effectively with rural communities and understanding the worries and concerns after which they are connected to the district authorities through processes of law.

Symbiosis Law School, Nagpur Legal Aid Centre Action Plan- 2021-2022

- ➤ The Legal Aid Centre of Symbiosis Law School, Nagpur will be active in three directions, i.e. legal awareness, legal literacy and core legal aid.
- ➤ An action plan of Legal Aid Centre of symbiosis law school in collaboration of DLSA will include;
- Opening of Pro Bono Club under the aegis of Ministry of Law and Justice, New Delhi.
- ➤ Legal awareness camps which will include awareness program on targeted groups through distribution of leaflet and street play and personal interaction. Such as awareness program on women's right in POSCO law and Domestic Violence Act.
- ➤ Value-added course on Disability Studies under the grant received.
- > Core legal help on case to case basis with the help of lawyers on panel suggested by DLSA.
- ➤ Visit to village near Nagpur city, Government schools to spread awareness about Right to Education, visit to Central jail, Balgruh etc. to spread the awareness program about their legal rights.
- > Street play on right to vote at railway station, bus station.
- > Two days' Workshop for Para legal training. (for Members).
- > Participation of students in Lok-adalats conducted by DLSA.

Legal Awareness Program on Traffic Rules

Legal Aid Centre at Symbiosis Law School, Nagpur in association with an NGO, Ishwarya organized a legal literacy campaign on traffic rules relating to pedestrians in Maharashtra on 18/09/2021. Students of the Legal aid Centre and members of the NGO participated in this drive with zeal and enthusiasm. Students also surveyed the area of Sakarrdara regarding pedestrian rules under the Motor Vehicle Act.

Pedestrians were made aware of their right to way and motor vehicle rules. Pedestrians have the right to way, especially at zebra and pedestrian crossings. If a road is without a footpath pedestrian should walk from the right side of the road. When a blind person is crossing the road, the driver of the vehicle shall consider the white cane as a traffic sign to stop the vehicle.

Under the Persons with Disabilities (Equal opportunities, protection of rights and full participation) Act (1995), the government must provide for auditory signals, engraving on the zebra crossings, slopes in pavements for easy access of wheelchair, and warning signals at appropriate places. Mr. Deepak Bhusari, Police Inspector, Sakarrdara Traffic Police Station also interacted with the students.

During the literacy program, the Legal Aid Centre found that,

- 1. Pedestrians are not effectively regulated at the signal as the zebra crossing is not imprinted on maximum squares.
- 2. Many signals are not indicating the signals for pedestrians to cross the road.
- 3. There are no auditory signals, engraving on the zebra crossings, slopes in pavements for easy access of wheelchair, and warning signals at appropriate places for disabled people.
- 4. Footpaths are encroached by vendors or not maintained properly. Hence the city is not pedestrian-friendly.
- 5. There is no penalty for pedestrians for violation of traffic rules.
- 6. The driver cannot claim compensation against the pedestrian if any damage is caused to the vehicle because of the negligence of the pedestrian. Moreover, a

pedestrian can claim compensation subject to the rule of no-fault liability and contributory negligence.

The event was conducted under the supervision of **Dr. Deepti Khubalkar**, Assistant Professor, SLS, Nagpur, and under the guidance of **Dr. Sukhvinder Singh Dari**, Director SLS, Nagpur. Not many traffic signals guide pedestrians at city squares: Study

PEDESTRIANS are not effectively regulated at the signal as the zebra crossing is not imprinted on maximum squares. Many signals are not indicating the signals for pedestrians to cross the road. There are no auditory signals, engraving on the zebra

crossings, slopes in pavements for easy access of wheelchair, and warning signals at appropriate places for disabled people. These are the inferences those have been drawn after

the legal literacy campaign on traffic rules relating to pedestrians in Maharashtra, organised by Legal Aid Centre at Symbiosis Law School, Nagpur in association with an NGO, Ishwarya.

Students of the Legal Aid Centre and members of the NGO participated in this drive with zeal and enthusiasm. Students also surveyed the area of Sakkardara regarding pedestrian rules under the Motor Vehicle Act. A detailed questionnaire was prepared for that purposes.

Pedestrians were made aware of their right to way and motor vehicle rules. Pedestrians have the right to way, especially at zebra and pedestrian crossings. If a road is without a footpath pedestrian should walk from the right side of the road. When a blind

person is crossing the road, the driver of the vehicle shall consider the white cane as a traffic sign to stop the vehicle.Under the Persons with Disabilities (Equal opportunities, protection of rights and full participation) Act (1995), the government must provide for auditory signals, engraving on the zebra crossings, slopes in pavements for easy access of wheelchair, and warning signals at appropriate places. 

Dr. Deepti Khubalkar, moderated the session and proposed the vote of thanks. More than 70 participants attended and provided very positive feedback about the webinar.





On Russia Ukraine War – A Humanitarian Crisis

Symbiosis Law school, Nagpur organized a peer to peer discussion on international relation affected because of **Russia –Ukraine conflict** and humanitarian concern on 4th March, 2022 in College moot court hall. The discussion was moderated by Mr. Himanshu Dhakad (President) Legal Aid Cell, Parag Kesharwani, (Vice- President) Legal Aid Cell and Jasraj Singh Bhatia (Community Head) Legal Aid Cell, SLS, Nagpur.

During the interaction students discussed the large-scale Russian invasion of Ukraine resulted in civilian losses, skyrocketing humanitarian needs, and one of the most significant new displacement crises in recent years.

Student argued that the Russia was well aware that Russia outnumbers Ukraine militarily and NATO would not send soldiers to Ukraine's aid, Europe's reliance on Russian oil and gas would make countries such as Germany wary of applying harsh penalties. There were also some arguments that Ukraine sees Russia leveraging this escalation to force more concessions from the West, and Kyiv is entertaining a revolving cast of European and US officials and getting arms shipments (including some helmets) by the day. Ukraine realizes better than anyone that it will not be joining NATO anytime soon and the main motive of Russia was to attack Ukraine just because of alliance with NATO.

Students debated that Russian threats and intervention have been a constant for Ukrainians, especially since Moscow's invasion in 2014. Beyond Russia, Ukrainians have their own domestic issues to contend with, including treason allegations currently

being levelled against a former president. The discussion got a good feedback from the students.

Institutional Social Responsibility (ISR Activity)

On April 16, 2022, the Legal Aid Centre at Symbiosis Law School, Nagpur organized an ISR activity by hosting a legal awareness program in Sarodaya Nagar, Nagpur. The event was held in association with DLSA, Nagpur, with the goal of addressing the legal issues that the community in the area was facing and providing free legal assistance through DLSA, Nagpur. Faculty in charge, Dr. Deepti Khubalkar along with the members of legal aid Centre visited people in the area and collected data relating to legal problem.

During the interaction with the people, it was found that residents in the area had purchased plots from the society 22 years ago, but were still waiting for the sale deed registration due to the Society's and the seller's non-cooperation. There are also no roads, pipelines, or gutters. There is no proper water supply system. The people are provided with water via a tanker that supplies water once a week.

Members of the Centre explained the people about the procedure of sale deed and requirement of registration at registrar's office. Both the buyer and the seller including the witness must be there at the registrar office on the date for the enrollment of the deed. The stamp duty and registration charges have to be paid for making the registration done. Further, the request was made to the elected area corporate to regulate the systematic water supply system, road construction and gutter line/ drainage system in the area to remove the difficulties faced by the people.

Members of the legal aid Centre participated in the ISR activity with enthusiasm. Mr. Parag Kesharwani, Ms. Simran Moryani, Mr. Saket Bansal, Riya Agrawal, Shivangi Mudra, Shambhavi Malya, Ritu Jaiswal, Aayush Rahate, Chetna Barat, Vedant Harde, Jahnavi, Adity Gote and Parth Gawde worked hard for the success of the event.





Change in Women's age of marriage from 18 to 21

Spreading legal awareness is one of the main goals of the legal aid center at SLS, Nagpur. To achieve this goal, the center has held a number of community-wide legal awareness programmes. Conducting discussion and debate on legal issues, is a constructive way to discuss various issues. The goal of increasing legal knowledge and exploring the prospect of reaching the people with the help of discussion.

To continue its initiation in this area, the Legal Aid Centre hosted a solution based thinking program शास्तार्थ -An Initiative to learn together on 21st April 2022 in the college Assembly hall at 4:00P.M.

The discussion was moderated by Mr. Himanshu Dhakad (President) Legal Aid Cell, Parag Kesharwani, (Vice- President) Legal Aid Cell and Jasraj Singh Bhatia (Community Head) and Riya Agrawal, Technical Head Legal Aid Cell, SLS, Nagpur. More than 50 students participated in the discussion. During the discussion various benefits as well as disadvantages and legal repercussions were exchanged. Students pointed towards the benefits as raising age will them adequate opportunity to education, marriage at early ages can also lead to the death of the mother due to pregnancy complications. So, raising the age of marriage for girls can reduce the chance of maternal mortality. Early marriages result in several mental health issues in many girls. So, this move can eliminate this problem.

The discussion got a good feedback from the students. The program was conducted under the supervision of **Dr. Deepti Khubalkar**, In charge, Legal Aid Centre.
