### **TAXPERT 2025 QUIZ COMPETITION ON "NATIONAL AND INTERNATIONAL TAX LAW"**

Symbiosis Law School Nagpur's Centre for Taxation Law organised a Intra Quiz Competition for students of LL.M., fourth year and Final Year Batch on 13 March 2025 from 03:00 P.M onwards at Assembly Hall of SLS, Nagpur premise. The Taxation Centre of Symbiosis Law School Nagpur successfully managed TAXPERT 2025 which functioned as a quiz competition to boost student understanding of tax regulations and modern amendments and practical applications winds.

TAXPERT 2025 encompassed four major taxation areas consisting of the Income Tax Act 1961, Goods and Services Tax (GST) system and International Taxation elements along with important precedents set by judges. Dr Aarti Kalnawat initiated the event through an inauguration which centred on explaining taxation's crucial role in legal practice.

Structure of the Competition The quiz competition consisted of three separate test segments whose purpose was to evaluate both the taxation expertise and analytical capabilities of participants.

1. First Round – MCQ-Based Test: The quiz consisted of a multiple-choice examination to evaluate fundamental taxation principles and legal provisions. The study moved forward to the following stage for participants who obtained the most points.
2. Second Round – Riddle Round: The round included entertaining puzzles based on taxation concepts. The round engaged participants in solving logical problems and evaluating their abilities to solve problems and their comprehension of several tax laws.
3. Third Round – Scenario-Based Questions (Final Round): At the end of this challenging segment participants received real-life taxation examples which they needed to analyse and generate legal solution recommendations. Participants had to demonstrate taxation law application skills combined with provision interpretation abilities and crucial thinking competencies under high-stress conditions throughout this segment.

The Quiz was conducted by members of Centre for Taxation Law, Ms. Vidhi Kapoor and Ms. Akshita, Mr Aadarsh was the score keeper and Ms. Akriti Rajesh Kumar taken care of arrangements and logistics.



Winners and Recognition The winners from TAXPERT 2025 received their honours after three demanding competition rounds concluded.
