REPORT

6TH INTERNAL MOOT COURT COMPETITION- 2024

We are delighted to share with you that Symbiosis Law School, Nagpur successfully conducted its 6th Internal Moot Court Competition on August 24, 2024. The competition was open for participation from four batches of students hailing from the second, third, fourth and fifth years at Symbiosis Law School, Nagpur. The Moot Proposition for the competition was based on Criminal Law, more particularly, law related to bail. The participants were given the liberty to form a team of three members consisting of two speakers (mooters) and one researcher. The participants were given one month for preparing their respective written submissions and oral arguments. The judging criterion for teams was three-fold i.e. it was based on the team's researcher's test, their written memorial submissions and their advocacy skills in oral rounds.

The Competition saw an overwhelming participation from 130 teams (390 students) across the four batches. The competition was judged by a panel of distinguished judges which comprised eminent lawyers and the faculty of the institution. The judges were impressed by the performance of teams and commended the teams for their hard-work and exposition. The competition was a great learning experience for all the participants. It enabled the students to indulge in an authentic simulation of an actual court with an aim to hone their advocacy skills. The competition reached its feat of refining the crucial qualities that are needed in the legal field like researching, drafting and presenting arguments through this endeavour.

After the oral round for the competition was concluded, the Moot Court Association of Symbiosis Law School, Nagpur released a merit list. **Team No. 115**, consisting of **Arnav Ashtikar, Arnav Naik and Shweta Jois**, were declared **Winners** of the competition, while **Team No. 08** comprising **Sanya Pandey, Yashasvi Vats and Aryan Srivastava** and **Team No. 71** comprising **Sanika Vipul Jadhao, Shubham and Garv Gautam**, bagged the second and third place respectively. The Best Speaker award was bagged by **Fareeha Badar**, the Best Researcher Award was bagged by **Aryan Srivastava** and the Best Memorial award was bagged by **Team No. 21** comprising of **Aadya Upadhya, Vani Khandelwal and Pujita Agarwal**.



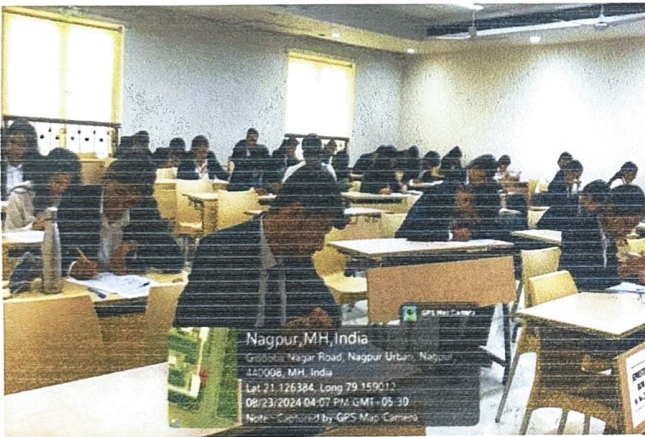
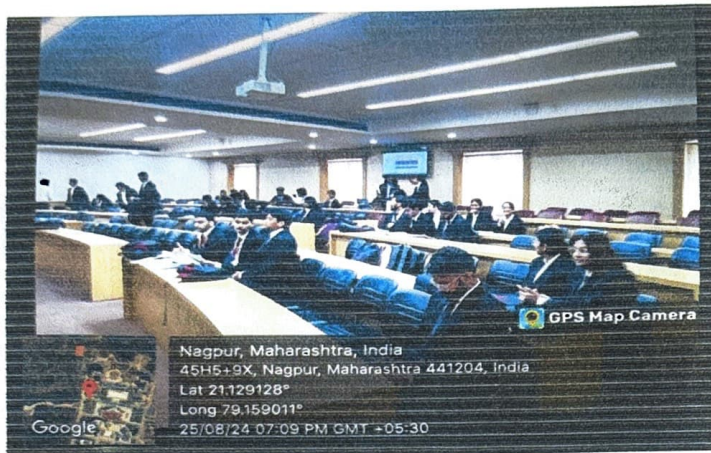
