## Symbiosis Law School, Nagpur Organised EDGE: A Placement Ranking Competition

On 29 September 2024, the Training & Placement Cell of Symbiosis Law School, Nagpur conducted an internal placement ranking competition for the students of Batch 2021-26, under its EDGE (Employability, Development, Growth and Experience) Placement Programme.

EDGE (Employability, Development, Growth and Experience) is a process designed to vet and prepare candidates opting for placement assistance at Symbiosis Law School, Nagpur, open to penultimate year students at SLS Nagpur. In the first stage, participants were assessed on the basis of their CGPA, internships undertaken, additional qualifications, extra-curricular and co-curricular achievements, and publications. 


