FRESHER'S MOOT COURT COMPETITION - 2025

Symbiosis Law School, Nagpur conducted the Fresher's Moot Court Competition – 2025 on 1st February, 2025. The competition was open for the fresher batch 2024-29 i.e., the students from first year at Symbiosis Law School, Nagpur. The Proposition for the competition was based on the combination of Constitution of India and Breach of Privacy. The participants were given the liberty to form a team comprising of three members consisting of two speakers (mooters) and one researcher and were given one month for preparing their respective written submissions. Participants were supposed to submit written submissions from both the sides, i.e., Complainant and Respondent teams was two-fold and was based on their written memorial submissions along with their advocacy skills in oral rounds.

The Competition saw the participation of 56 teams from the first-year batch. Before the commencement of the competition, a workshop was conducted for the participants, to give them an opportunity to get in insight into the intricacies and learn about memorial drafting and art of mooting. The primary objective of the competition was to improve the writing, research, analytical and oral skills of the students and the purpose was to give the participants an experience of simulation to test and further enhance their research, drafting and mooting skills. The competition reached its feat of refining the crucial qualities that are needed in the legal field like researching, drafting and presenting arguments through this endeavour.

After the oral round for the competition was concluded, the Moot Court Association of Symbiosis Law School, Nagpur released a merit list nominating the teams on the basis of their absolute ranks. Team No. 13 comprising of Siddhant Jog, Anagha Chopra and Kshyapi Bansal was declared winner of the competition, while Team No. 11 comprising of Ananya Mohan, Manya Chhabria and Dhwani Gandhi and Team No. 01 comprising of Ayesha Anjum, Taiba Shaik and Shaik Afreen backed the second and third place respectively.
