Event Report: Lecture on New Approaches and Ideas on Human Dignity: An International Comparative Perspective by Dr. Krystian Complak

On 16 October 2024, the International Cell at Symbiosis Law School, Nagpur, organized a highly engaging online lecture as part of its International Lecture Series. The session, "New Approaches and Ideas on Human Dignity: An International Comparative Perspective," was delivered by Dr. Krystian Complak, a distinguished Professor of Constitutional Law at the University of Wroclaw, Poland. He emphasized how these legal systems interpret human dignity in varying cultural, political, and historical contexts.

The lecture also delved into the role of constitutional courts in protecting human dignity. Dr. Complak illustrated how judicial review in various countries plays a crucial role in upholding human dignity, often shaping the constitutional landscape through landmark decisions that reflect contemporary understandings of dignity.


