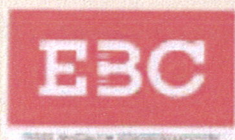

The Moot Court Association of Symbiosis Law School, Nagpur organized its 6th National Moot Court Competition and this time in collaboration with the National Human Rights Commission from 23rd February 2024 to 25th February 2024. The NHRC-SLS, Nagpur National Moot Court Competition received a tremendous response as the competition received over 95 registrations from several Law colleges across the country. Based on the memorial round, 20 teams were selected for the oral rounds.

INAUGURATION

The Competition was inaugurated at the hands of the chief guest of the ceremony, Hon'ble Shri. Justice V.C Daga, Former Chief Justice, Bombay High Court and the Guest of Honour Dr. Dnyaneshwar Manohar Mulay Sir, member National Human Rights Commission, on 23rd February 2024. The Guest of Honor and the Chief guest of the event both shared some invaluable insights and experiences with the students of SLS, Nagpur and the participating teams and marked the beginning of the 6th National Moot Court of Symbiosis Law School, Nagpur. The Inauguration ceremony was followed by the researcher's Test which was based on the moot preposition, Human Rights and Constitutional Law.

This collaboration between Symbiosis Law School, Nagpur, and the National Human Rights Commission marks a significant milestone in our journey towards promoting excellence in legal education and advancing the cause of human rights.

PRELIMINARY ROUNDS

The competition received over 90 registrations and after the Memorial round 20 teams qualified for oral rounds. The journey of these 20 teams started with preliminary rounds where all the 20 teams locked horns against each other to decide who will proceed further to qualifying rounds and take their first step towards the ultimate glory.

QUARTER FINAL ROUNDS

The completion of Preliminary Rounds was followed by the Quarter Final Rounds, on the same day, where the eight (8) best teams of the preceding round qualified for this round which is a step-further towards ensuring fulfillment of the aspirations of the young and energetic participants to reach towards the final and win the National Moot court Competition by Symbiosis Law School, Nagpur in collaboration with National Human Rights Commission (NHRC).

FINAL ROUND

The semi-final of the event was followed by the most awaited final round of the prestigious National Human Rights Commission (NHRC) – Symbiosis Law School, Nagpur National Moot Court Competition. The top two teams after competing hard through all the rounds reached the final round and now it was the time for them to *land one final punch* for the quest of the ultimate glory. Both the finalist teams showed some high class of mooting skills and there was a cut-throat competition between both the teams to win the final round.
