"अयं निजः परो वेषु गणना लघुचेतसाम्। उदारचरितानां तु वसुधैव कुटुम्बकम्॥"


This shloka, derived from ancient Indian scriptures, emphasizes the idea of universal brotherhood. It translates to:


"This is mine, and that is yours—such calculations exist only in the minds of the narrow-minded. For those with a broad outlook, the whole world is one family."


