### Report on Training Workshop on New Criminal Laws in India

27th June 2024

#### Session One: Bhartiya Sakshya Adhinyam

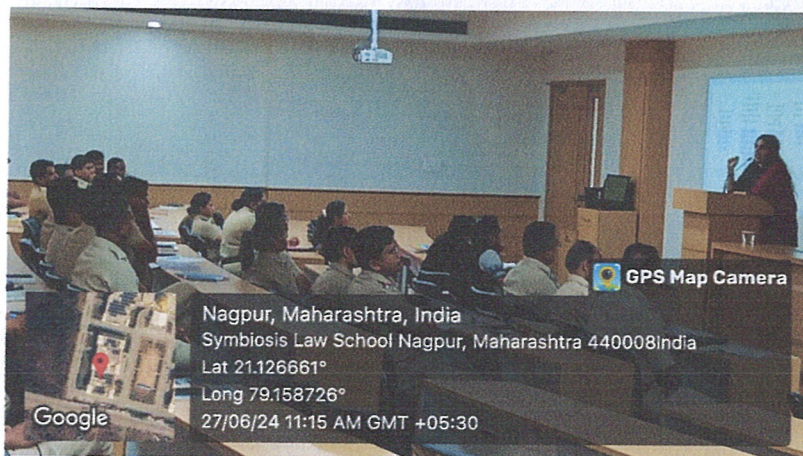

### Session Two: Bharatiya Nyaya Sanhita,

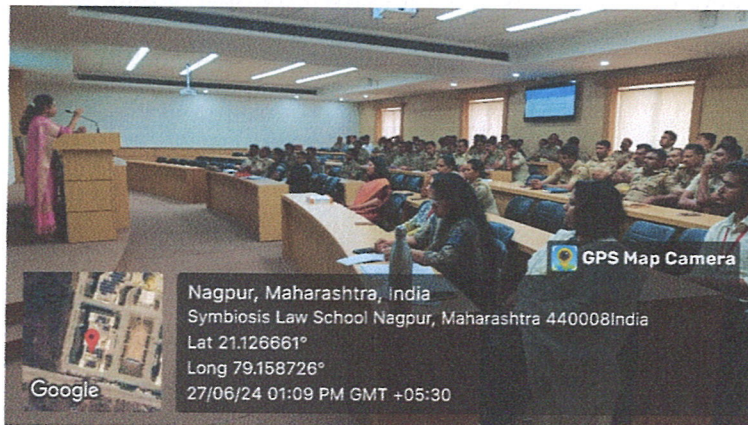

The session was concluded with a Q and A in which questions related to the application of the new law and the newly introduced punishment of community service were asked by the participants

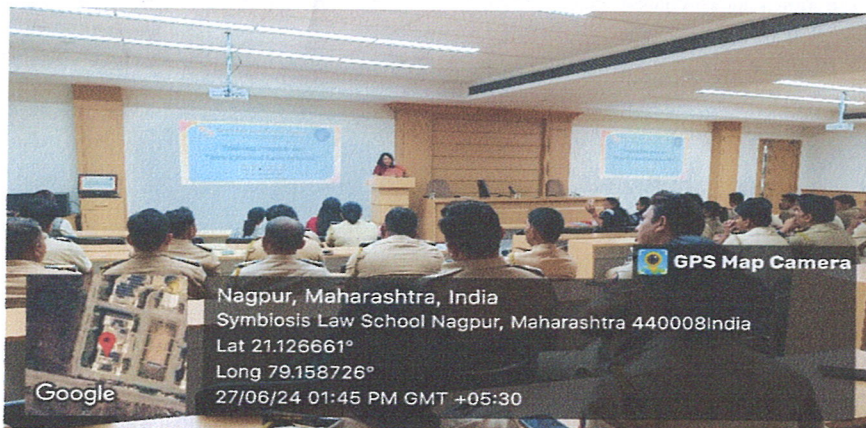
### Session Three: Bhartiya Nagrik Surakshta Sanhita.

Dr. Abhilasha Khare addressing the gathering on BNSS.

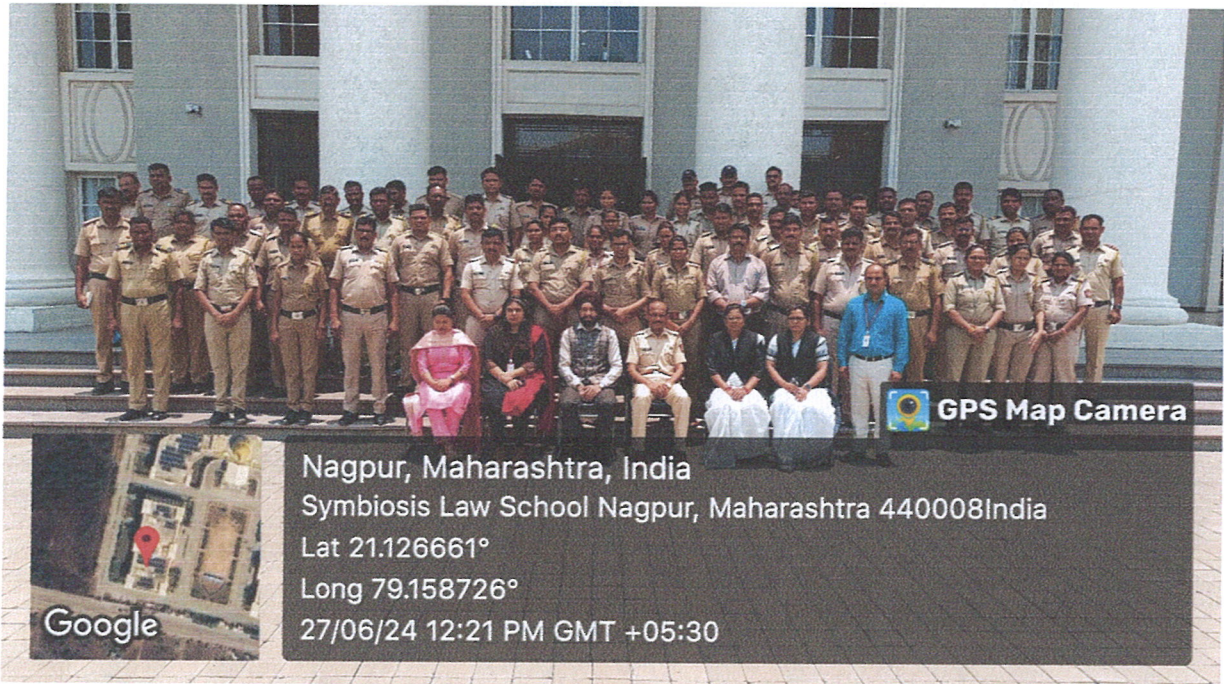
