



Mr. Abir Lal Dey and Mr. Aroop Das swiftly proceeded to shed light on the underlying rationale behind project financing and its major correlation with heavy infrastructure projects. This effectively laid a strong foundation for a nuanced discourse relating to project finance whereby the students learned about the types of project financing and also, the types of security interests that are involved in project financing.


Weeklong interaction with alumni/field experts of batch 2019 - 2024


BOOK EXHIBITION



He explained the participants in which cases mediation is permissible and not permissible with examples. Adv. Borkute explained mediation in family matters. She also explained the provisions under civil procedure code under section 89(2) in Part X and rules relating to mediation and binding effects of mediation.




INTERACTIVE SESSION ON INTRODUCTION TO INTELLECTUAL PROPERTY RIGHTS




1st INTRA LEGAL AND BUSINESS CONFERENCE AT SYMBIOSIS LAW SCHOOL, NAGPUR






The workshop commenced with the welcome address by **Dr. Sukhvinder Singh Dari**, Director, Symbiosis Law School, Nagpur.


SECOND INTRA COLLEGE DEBATE COMPETITION THE POLEMIC

APRADH – DOCUMENTARY SCREENING


